► Following a request from the European Food Safety Authority (EFSA), the EFSA panel on Biological Hazards (BIOHAZ) was asked to deliver a scientific opinion on the public health risks related to the consumption of raw milk. The BIOHAZ panel was, in particular, requested to identify the main microbiological hazards related to the consumption of raw milk from different animal species, to identify the risks associated with the sale of raw milk through vending machines and via the internet, and to identify and rank potential control options to reduce the public health risks arising from consumption of raw milk.
